ITEM NO.3 DECISION TAKEN IN THE 17TH BOARD OF RESEARCH MEETING

3.1 Admission to Ph.D under Distance Education mode.

Keeping in view the reputation of the University and to ensure quality in research, it has been decided that admission to Ph.D, with candidates who completed their degree in distance education mode is not considered.

3.2. Issue of Equivalence Certificate

The Ph.D degree certificate should be awarded only under a specific Faculty. If request is received from the individual for issue of equivalence certificate with a mention on specialization, a committee can be constituted to decide on the area of specialization. An official letter can then be issued to support the Ph.D degree certificate in order to benefit the candidate.

3.3. Exemption from Sathyabama Entrance Examination for Candidates with Valid GATE, GRE, GMAT Score.

Indian Resident Candidates with valid GATE Score is exempted from Ph.D Entrance Examination. For NRI Candidates they have to take Sathyabama entrance examination with a flexibility on the date of examination, but should be completed prior to the completion of admission procedure for that session.

3.4. Re-registration - Procedures

A candidate whose registration has been cancelled and has taken a new admission is considered as a fresh registered candidate only and there is no re-registration procedure. He/She cannot be exempted from coursework. The duration of Ph.D programme can be relaxed by one year from the minimum time period provided the candidate produces high impact factor publication. (Impact factor greater than 5).

3.5. Migration/Transfer from another University to Sathyabama Institute of Science and Technology

Transfer from one university to another university is not allowed. One has to register as a fresh candidate in the new university.

3.6. Exemption Request for Coursework- Post Graduate Certificate in the Teaching of English (Jyothi Masuram - 2018199101)

As per the university norms a candidate has to complete four course works. No exemption is to be given for any of the certificates produced equivalent thereto except NPTEL courses.

3.7. Publication in Journals under Emerging sources

Publication in Journals under Emerging sources is not allowed. Any publication in a journal with citation index only will prove a quality research.

3.8. Number of Credits for course work

As per UGC notification received in December 2019, two credit course entitled " Research and Publication Ethics (RPE)" is to be included as a compulsory course work for all Ph.D students. In view of this, board has recommended to rename the course titled "Research methodology Tools and Techniques" as "Research and Publication Ethics".

Mode of Study is not to be included for award of Ph.D degree.

3.10. Decision on the Faculty for award of Ph.D Degree

If the candidate's research is interdisciplinary, decision on the faculty for award of degree is to be decided by constituting an expert committee.

3.11. Plagiarism Checking for Thesis

Similarity index checking for thesis can be done by Turnitin software or Urkund software, but care to be taken whichever software gives high percentage of plagiarism.
